

Instruction Sheet - Medical Doctor Package

The newly launched **Medical Doctor Package**, available in both document and brochure form, has been created by a group of scientists, medical professionals and data analysts. It summarizes and simplifies this recently released data from Pfizer, in addition to the adverse event following immunization reporting form. **Please read it for yourself. You can come to your own conclusions.**

What is in the Medical Doctor Package?

- **Intro Page:** write name and address of who it is being delivered to
- **Medical Doctor Package PDF:**
 - **Cover Letter:** an easy-to-read summary of Pfizer's post-authorization adverse events report, and the legal requirement for physicians to report adverse events under the *Public Health Acts and Regulations*
 - **Pfizer Document:** BNT152b2 Cumulative Analysis of Post-Authorization Adverse Events report - Reveals over 1200 adverse events of special interest related to the Covid-19 injection, including neurological and cardiac conditions, and death. Please review the pregnancy and fetal outcome data presented.
 - **CDC and Public Health:** Adverse Events Reporting forms legally required to report and submit to Public Health offices regarding adverse health effects following immunizations, including the Covid-19 injections
- **Informed Consent brochure:** the 'brochure' form of the Medical Doctor Package is easy to read with access to links to relevant information regarding Pfizer's report, informed consent, reporting form, "Am I Vaccine Injured?" and health solutions.

When to share the Medical Doctor Package? Now is the time. Individuals experiencing health decline since receiving the Covid-19 injection are beginning to understand that they are not alone and seeking information. There are health solutions available to help heal and detox the body post-vaccine and financial assistance through vaccine injury financial support programs.

How to share the Medical Doctor Package (MDP):

1. PREPARE – Documents to prepare.

- a. Determine where and to whom you want to deliver to (doctors, pharmacists, front line workers, other health care, clinics).
- b. Find the address/email/fax based on how you want to deliver. In person is best but there are a few more steps involved.

Visit the Health & Sciences website to get the most up to date documents to share at www.medicaldoctorpackage.com. Other supportive documents, such as scripts, Q&A, and how to create delivery lists, are available to help you feel prepared.

- a. **For email or fax** – can be done electronically or print PDF to email or fax directly from your phone/device/computer.
- b. **In person** – 1.) Print the three documents – Cover Sheet, MDP (Cover letter and Pfizer AE document), brochure. 2.) Label 9" x 12" envelope "Personal & Confidential" with name of recipient. 3.) Prepare an envelope for each recipient. For pharmacies, prepare the envelope but you may be able to speak to them directly. Use an extra MDP package to present the contents of the package. Deliver packages on your own or with another person.

2. DELIVER – How to share this information. Please deliver with kindness and professionalism.

- a. **In-Person: What to say?** Be yourself. In a medical clinic, kindly ask the receptionist to put one MDP package in each physician's mail slot. Then show them the brochure and point out the highlights of Pfizer's data. If you are able to speak face to face to a medical professional, you could say *"I came across this recently published information directly from Pfizer and it looks very important for us all to be aware. Could you review and let me know what you think, as I respect your expertise."*
- b. **Email/Fax:** Although in-person deliveries are best, the documents can be emailed or faxed. Include the Cover Sheet with this note: *As my family physician/health professional, I feel that it is important for you to be aware of Pfizer's Post-authorization Adverse Events Report (attached below). This information of adverse events is essential in informing your patients of the risks of taking the Covid-19 vaccine with mRNA technology. Knowledge of these adverse events will help with proper reporting for those who may have experienced health changes. Thank you for your time.*

3. SUBMIT YOUR RECORD OF DELIVERY - How to report your deliveries

- a. **Submit delivery report:** fill in online form of who you delivered the package/brochure to: www.unitymovement.ca/MDP-Delivery
- b. **Details include:** date, your name/email, recipient's information, and any notes about the delivery.
